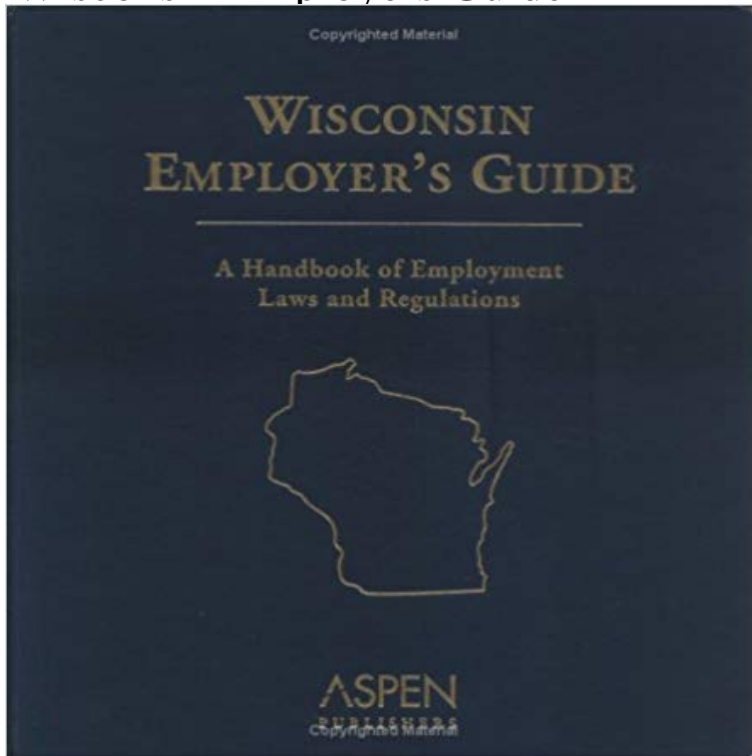


Wisconsin Employers Guide
